1) 1-foot Drawdown Project.

The Washburn County Hwy Departments plan to perform a 1-foot lake-level drawdown has been postponed from the week of September 17th, to the week of October 1st due to recent heavy rainfall amounts. This drawdown's specific purpose is to enable assessment of possible repair work on a portion of the dam that was not replaced at the time the new dam was constructed.

2) 5-foot Drawdown Analysis Project.

The analysis of a possible 5-foot lake-level drawdown for the purpose of Eurasian Water Milfoil (EWM) control continues. We are currently awaiting the DNR's response to our permit request. Presuming that this permit garners approval, there is still a great deal of planning to be completed before any such event will occur.

Note that the earliest potential season for a 5-foot winter drawdown is 2019/2020.

There will NOT be 5-foot winter drawdown for the purpose of EWM control in the coming winter season.
